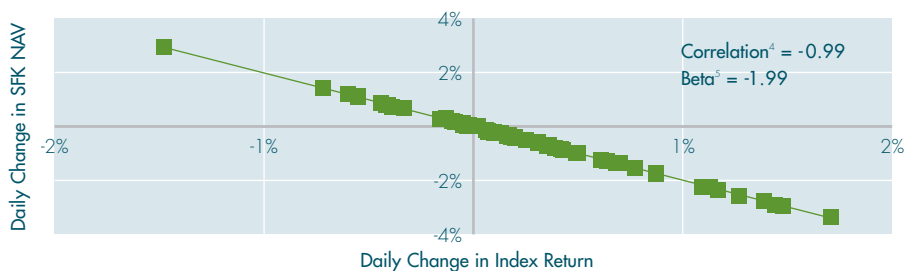
FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraShort Russell1000 Growth seeks a return that is -2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. 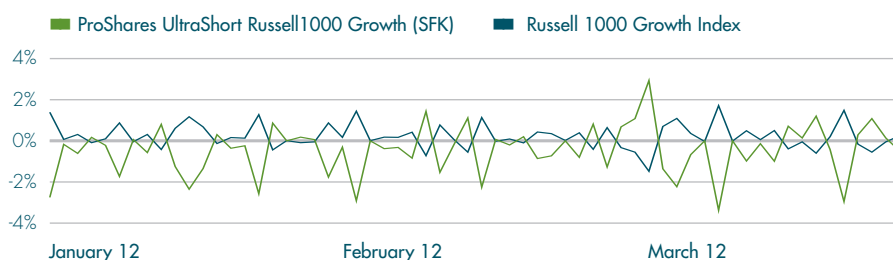

The Russell 1000 Growth Index measures the performance of those Russell 1000[®] companies with higher price-to-book ratios and higher forecasted growth values.

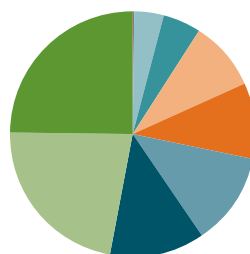
