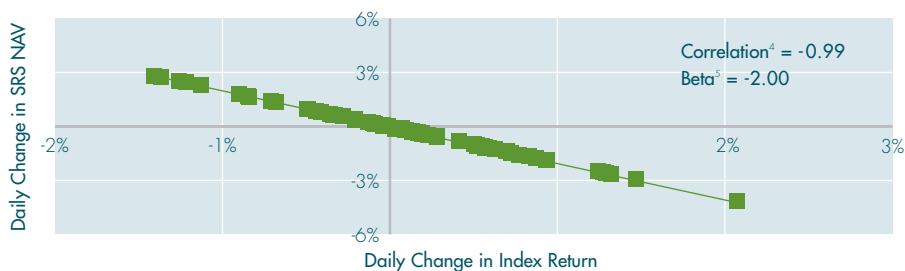
### FUND PERFORMANCE AND INDEX HISTORY

ProShares UltraShort Real Estate seeks a return that is -2x the return of an index (target) *for a single day*, as measured from one NAV calculation to the next. Due to the compounding of daily returns, returns over periods other than one day will likely differ in amount and possibly direction from the target return for the same period. These effects may be more pronounced in funds with larger or inverse multiples and in funds with volatile benchmarks. 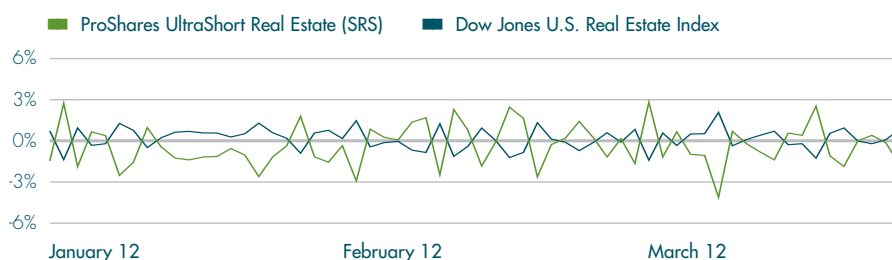

## INDEX DESCRIPTION

The Dow Jones U.S. Real Estate Index measures the performance of the real estate industry of the U.S. equity market. Component companies include those that invest directly or indirectly through development, management or ownership of shopping malls, apartment buildings and housing developments; and real estate investment trusts ("REITs") that invest in apartments, and office and retail properties. REITs are passive investment vehicles that invest primarily in income-producing real estate or real estate-related loans or interests.
